**POPS GUN CLUB, INC
APPLICATION FOR GOLD MEMBERSHIP**

This application for Gold Membership to Pops Gun Club is good for one Year. The document entitles one immediate family to join and shoot at Pops Gun Club Inc. after board approval. You may shoot before board approval of your application. In the case that the board does not approve your Gold Membership, \$400.00 dollars will be returned to you and the gun club will process your application as a general application for membership. Each family will receive 1 key to the gate and a Gold Member ID Card. Gold Members are entitled to shoot at any time that the calendar states "Gold". Holidays are excluded. Gold Members may not bring guests. Gold Members are required to attend orientation. The Primary Gold Member must be a NRA RSO, or equivalent. By becoming a Gold Member you will be supporting Pops Gun Club and become a member of an organization that educates its members and supports shooting sports. In addition, you will support the existence of private ranges in the State of Florida and help maintain your right to enjoy shooting. This application for membership is an entitlement to shoot on "Gold" days. The cost to join the club is \$500.00 per family. This includes your spouse and your minor children. (under 24).

Special event shoots; competitions and training classes are excluded from this contract; however, Gold Members will receive a 5% to 20% discount depending on the event, or shoot. Training classes that are offered by outside instructors do not receive a discount.

Every member agrees to participate in service work of a minimum of 5 hours per year. Those that choose to forgo service work may give a donation to our building fund in the amount of \$100.00. Funds will be used to improve the range and improve the grounds for our membership.

From time to time it may be necessary to assess the membership in emergencies for legal fees, or various other needs. The proposed assessment will be preceded by a member meeting and voted on by the general population of members before such assessment will be imposed.

Every member will be issued a member card with power to vote. No member holds any interest in the physical property in which the gun club is situated. Gold Memberships are transferable. In the case that you must sell your membership please let the buyer know that approval of the board is required before any use of the facility is allowed.

We are a NRA affiliated business that strictly adheres to NRA Safety Rules. Every member will be responsible to learn and practice safety. Our instructors are here to

teach safety, but every member and guest has a responsibility to learn and adhere to all our gun club rules. Disciplinary actions will be adhered to in the case that A NRA RSO deems necessary.

Every member is to pick up their own mess and dispose of all items. All membership applications shall be legible with a good email and phone number. This application does not contain all of the by-laws of the gun club. You may pick up the by-laws in the club office.

The Range Part- Hold Harmless and rules
